Revised/New Items - Combined IV-D Policy Manual Item 115, Cooperation, Non-Cooperation, and Disqualifications.

Attached is the Item 115 for the new combined manual, Combined IV-D Policy Manual. This item replaces the current Item 160, OCS Manual; Chapters 210, 220, and 225 of the FOC Manual; Item 110 of the PAH.

This item is also a part of the new numbering structure of the IV-D Combined Manual format. Attached is a new, proposed Table of Contents for the first series in the Combined IV-D Manual: Series100, IV-D Eligibility and Procedures. This Table of Contents is constantly being revised at this point and is subject to change.

Attached is the Item 120 for the new combined manual, Combined IV-D Policy Manual. This new item replaces OCSM Item 150, parts of MFOC Chapters 210,220,.225,230; parts of PAH Items 140,200,230,240.
