#### PURPOSE:

This IV-D Memorandum announces a new interface between the Michigan Child Support Enforcement System (MiCSES) and the Bureau of Construction Codes (BCC) system. BCC is one of the licensing systems for the Michigan Department of Licensing and Regulatory Affairs (LARA). This IV-D Memorandum introduces the BCC license types and secondary statuses that LARA will add to its professional license interface with MiCSES. This license data will be added with the Child Support 23.1 Release on March 10, 2023.

Additionally, this IV-D Memorandum introduces license types that previously migrated from the License 2000 (L2K) system to the Michigan Professional Licensing User System (MiPLUS) but were not visible to IV-D workers in MiCSES.<sup>1</sup> These license types will be available in MiCSES with the 23.1 release.

### **DISCUSSION:**

### A. Background

LARA has been migrating license data from L2K to new licensing systems since June 2017. The final migration from L2K to MiPLUS occurred in October 2021. LARA continued to move license data to other new licensing systems until 2022.

IV-D workers use professional license data in MiCSES to:

- Enforce child support orders;
- Locate non-custodial parents;
- Estimate income when calculating support;
- Evaluate the ability to pay; and
- Suspend professional licenses.<sup>2</sup>

IV-D workers can view license data on the *Member Licenses* (MLIC) screen<sup>3</sup> and in the *License Description* field on the *Contempt Ability to Pay Screening* (CAPS) screen.<sup>4</sup> License information is also available in the following Business Objects reports:

- Proactive Locate Licensing Report (LC-012);<sup>5</sup>
- Member Income and Location Report (LC-001) (MILR);<sup>6</sup> and
- Income and Location Report (LC-002) (ILR).<sup>7</sup>

### **B. BCC License Types and Secondary Statuses**

On March 10, 2023, LARA will add BCC license types and secondary statuses to its professional license interface with MiCSES.

1. New License Types

The interface between MiCSES and BCC will include the following license types:

2. New Secondary Statuses

The following secondary license statuses<sup>8</sup> that are unique to BCC licenses will be available with the new interface:

- Issued;
- Hold;
- Section 2405 Suspension;
- Suspended; and
- Voluntary Inactive.

### C. MiPLUS License Types

Some license types that previously migrated from L2K to MiPLUS were not visible to IV-D workers in MiCSES. These license types will be available to IV-D workers in MiCSES on March 10, 2023:
