	<b>Respect</b> means to show deferential regard for; to be treated with esteem, concern, consideration or appreciation; to protect the individual's privacy; to be sensitive to cultural differences; to allow an individual to make choices.

	It is the policy of the MDHHS that all recipients of services in its hospitals and centers and their family members shall be treated with dignity and respect.

	3.	All department employees, volunteers, contractual service providers and employees of contractual service providers shall treat recipients and their family members with dignity and respect, being sensitive to conduct that is or may be deemed offensive to the other person.	
	4.	In addition to the above, showing respect for family members shall include:	
		a. Giving family members an opportunity to provide information to the treating professionals.	
		b. Providing family members an opportunity to request and receive educational information about the nature of disorders, medications and their side effects, available support services, advocacy and support groups, financial assistance and coping strategies.	
	5.	Information shall be received from or provided to family members within the confidentiality constraints of Section 748 of the Mental Health Code.
