1) DHS-4025, CHILD DEVELOPMENT AND CARE (CDC) PROVIDER VERIFICATION REQUIRED

The begin date of care must now be verified with the DHS-4025, Child Development and Care (CDC) Provider Verification, before child care authorizations can be entered on CIMS. The form must be completed by all provider types, including centers, group and family homes, day care aides and relative care providers. It must be signed by both the provider and parent/substitute parent to certify that the information is correct.

In addition to verifying the begin date of care, the form is used to provide information about the children in care, where the care is provided, reimbursements the provider receives on behalf of the children in care, and to document relative status. It should be filed in the CDC case file.

When a client requests an application for CDC in person, the local office must give the client a DHS-4025 that same day. When a client requests an application for CDC by letter or telephone, the DHS-4025 must be mailed to the client by the end of the next workday.

Reason: Program integrity.

Old Policy: Use of the DHS-4025 was optional.
